- 3. The parents and relatives of the candidates are barred for entry in the hall.

Candidate must bring all the original documents (School leaving certificate, No Objection Certificate from competent authority for Tutor working in B.J.Medical College/NHL Medical College/LG(AMC MET) Medical College, For In Service Candidates, study leave / resignation or NOC (As per Rule7.8), Internship completion certificate, MBBS Mark sheet all year, Attempt Certificate, GMC Registration Certificate, Certificate of completion of PG Course If Applicable)with same sequence & same should kept in one big envelop. Merit no., Full Name, Full Permanent Address, Mobile Number with all other details should be Mentioned on envelops.
- 7. Verification of all the original documents & undertaking (Attached herewith) on Stamp paper of Rs.20/- as per rule 7.13 of Post graduate admission will be done before counseling. Any candidate failed to produce any original document/undertaking will not be included for admission process. The envelope containing all original documents will be kept by the respective Institute if candidate will get the admission in any branch.
- 8. The Candidate should come with Rs.65,000/- (Rupees sixty five Thousand only) in cash.
 - As a part of University Registration fee [Rs.18348/- (Male/Female Candidates),
 Rs.15348 (Female Candidates for Govt. Institutes only)] and tuition fee/ Deposit as applicable.
- 9. After completion of selection process, the candidate will be called again for allotment of P.G teacher as per merit. After allotment of P.G. Teacher, the admission committee will

- give the admission order to the candidate. After getting admission order the candidate must join the institute in time limit prescribed in admission order.
